The tentative run order can be found at DoRightSecretary.com. The final run order will be constructed after move ups close on Monday January 24, 2022 and posted on DoRightSecretary.com under the Running Order heading.

Printed maps will not be provided at the trial. The maps will be posted on Agility Gate each day and on DoRightSecretary.com. Printed copies will be posted in the main building at All Star Dog Sports and in the crating Annex.

In addition to using the Agility Gate app, the run order will be displayed each day at the trial on a monitor to make the running order available to all exhibitors. If you are unable to check in via the Agility Gate app, any exhibitor with the app can check you in, or you can request that the Gate Steward check you in.

RIBBONS, AWARDS, AND PRIZES

Ribbons will be awarded to 1st through 4th place dogs in each jump height in each titling class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

1 ST Place.....	Blue
2 nd Place.....	Red
3 RD Place	Yellow
4 th Place	White
Qualifying	Dark Green

Rosettes will be awarded to all dogs completing a title. Double-Q Rosettes will be awarded to any dog qualifying in both rings (Std and JWW) in the same class. Commemorative MACH or PACH ribbons and bars will be awarded to any dog finishing a MACH or PACH title at these trials. PAX Rosettes will be awarded to any dog finishing a PAX title at these trials. The Club will offer a rosette and bar for dogs earning the Agility Grand Champion title.

AKC HEIGHT CARDS

All dogs competing in agility must **possess** an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. All dogs (except those jumping 24" or 26") without jump height cards/forms must be measured/wicketed by the Judge of Record PRIOR to running in their class; this measurement will be valid for the weekend of trials only. If a Volunteer Measuring Official or an Agility Field Rep is present, all dogs without a valid jump height card/form must be measured at some time during the trial. If the dog cannot be measured by the VMO prior to running, it must be measured by the judge before its first run.

- **You are not required to show your height card or send a copy with your entry.**
- **You are required to mark on your entry form if your dog needs to be measured.**

MEASUREMENT CHANGES DUE TO COVID

Measuring of Dogs: As of March 1, 2021 if a VMO or Agility Field Representative is measuring dogs at a trial, all present and entered dogs without a valid measurement must be measured. Until further notice, Judges of Record who are not VMOs do not measure dogs.

BITCHES IN SEASON

Bitches in season are not permitted to compete in Agility Trials. Entry fees less \$10 administrative fee and applicable AKC recording fees per day will be refunded for bitches coming in season after the closing date. Owner must present certificate from veterinarian prior to start of show.

FIX 'N GO ON (FNG)

Fix and Go On will be supported at this trial.

Fix and Go On is being offered on a one-year pilot basis in order to give the AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather it occurs during the course of the run.

FOR EXHIBITION ONLY (FEO)

FEO will be supported at this trial.

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

- **The safety of the dogs** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.
- Greater Kansas City Dog Training Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- Greater Kansas City Dog Training Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against Greater Kansas City Dog Training Club or any official thereof.
- **All dogs must be on leash or crated** at all times when on trial grounds except when in the designated warm-up area or competing on the course. **Please limit the use of flexi-leads to exercising dogs outdoors.**
- Greater Kansas City Dog Training Club may cancel this event in extreme weather conditions.
- Covid Restrictions which will be followed at the trial can be found on the secretary website for this trial at DoRightSecretary.com.

REFUNDS

- **No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- **Bitches in season** are not permitted to compete in Agility Trials. Entry fees less \$10 administrative fee and applicable AKC recording fees per day will be refunded for bitches coming in season after the closing date. Owner must present certificate from veterinarian prior to start of show.

RINGSIDE

- **Dogs may arrive** any time prior to judging whether they have a height card or not. As of March 1, 2021 if a VMO or Agility Field Representative is measuring dogs at a trial, all present and entered dogs without a valid measurement must be measured. Until further notice, Judges of Record who are not VMOs will not measure dogs.
- **Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Greater Kansas City Dog Training Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

ADDITIONAL SITE INFORMATION

- **BUILDING:** The building is climate controlled; indoor restrooms.
- **BUILDING SET-UP INFORMATION: THE BUILDING WILL NOT BE AVAILABLE FOR GENERAL SET-UP ON THURSDAY.** The building will open at 8:00 a.m. Friday morning.
- **CRATES** may be left overnight; however, Greater Kansas City Dog Training Club will not be responsible for any lost or damaged items left at the show site. No dogs allowed overnight in the building. Indoor crating is available in a climate-controlled crating room on the south side of ASDS. Crating might be a little tight at the site, so please conserve space by using wire crates and stacking crates whenever possible. Also, please leave the area along the tree line on the south side of the parking lot for exhibitors crating out of their vehicles. More information about crating set-up will be included in the confirmation letter.
- **Electronic Timing:** Electronic timing will be used at these trials.

- **PARKING:** There is close parking, but please park conservatively. Please reserve parking along the south tree line for exhibitors crating out of vehicles.
- **RV PARKING:**
 - **Overnight RV parking** is not allowed at the trial site.
 - **Limited daytime parking** is allowed for small RVs. Please contact Kim Krohn, 816-830-0573.
 - There are RV parks in close proximity to the show site in the Jackson County Parks System at [Blue Springs Lake](#) and [Lake Jacomo](#). The Jackson County online registration page for campgrounds can be located by clicking [here](#). There are also private RV parks in Grain Valley, Oak Grove, and Odessa.
- **FOOD:** Please feel free to bring in outside food. There will be lunch and drinks available for workers. There are fast food and sit-down restaurants within close driving distance.
- **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available.
- **VENDING:** There isn't space available for vendor tables but feel free to bring items to sell out of your vehicle or promotional information on your products. Please contact Kim Krohn at 816-228-1512 or krohndog@swbell.net with questions.
- **VOLUNTEERING:** Please volunteer to work. Workers will be supported with lunch and drinks if then turn in a lunch order form. Please sign up using the volunteer spreadsheet located on the secretary website DoRightSecretary.com or by clicking [here](#).
- **SPECTATORS:** Spectators will not be allowed to have their dogs with them. Dogs must be crated unless you are waiting to run, are running, or are exercising your dog(s). No other dogs will be allowed in the spectating area.

FOOD

- There are fast food restaurants and sit-down restaurants within 5 minutes of the show site.
- There will be lunch, snacks, and drinks available for workers. Please feel free to bring in outside food.

DIRECTIONS TO THE TRIAL SITE

- Please be aware that some navigation devices do not know the correct location for All Star Dog Sports. It is advised that you look at a map and find the location before trusting your phone or GPS.
- The site is **located** south of the city of Blue Springs on Highway 7, **just south of the intersection of Hwy 7 and Wyatt Rd, on the west side of Hwy 7.**
- If you are coming from the north (I-70), it is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.
- If you are coming from the south, it is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of the Storage Mart storage facility. Hwy 7 is divided by a median so it will be necessary to drive north of the site and make a U-turn at Wyatt Road.
