- **Electronic Timing**: Electronic timing will be used at these trials.
- PARKING: Please reserve parking along the south tree line for exhibitors crating out of vehicles.
- RV PARKING:
  - o Overnight RV parking is not allowed at the trial site.

#### **DIRECTIONS TO THE TRIAL SITE**

- Please be aware that some navigation devices do not know the correct location for All Star Dog Sports. It is advised that
  you look at a map and find the location before trusting your phone or GPS.
- The site is located south of the city of Blue Springs on Highway 7, just south of the intersection of Hwy 7 and Wyatt Rd, on the west side of Hwy 7.
- If you are coming from the north (I-70), it is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.`
- If you are coming from the south, it is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of the Storage Mart storage facility. Hwy 7 is divided by a median so it will be necessary to drive north of the site and make a U-turn at Wyatt Road.
