ADDITIONAL SITE INFORMATION

- **BUILDING**: The building is climate controlled; indoor restrooms.
- **BUILDING SET-UP INFORMATION**: **THE BUILDING WILL NOT BE AVAILABLE FOR GENERAL SET-UP THE DAY BEFORE THE TRIAL.** The building will open at 7:30 a.m. Saturday morning.
- The American Whippet Club will not be responsible for any lost or damaged items left at the show site. No dogs allowed overnight in the building. Indoor crating is available in a climate-controlled crating room on the south side of ASDS. Please leave the area along the tree line on the south side of the parking lot for exhibitors crating out of their vehicles.
- **Electronic Timing**: Electronic timing will be used at these trials.
- **PARKING**: Please reserve parking along the south tree line for exhibitors crating out of vehicles.
- **RV PARKING**:
 - **Overnight RV parking** is not allowed at the trial site.
 - **Limited daytime parking is allowed for small RVs. Please contact Barbara Stockard, Call or text 785-806-7617 or email agilewhippet@gmail.com for instructions**
 - There are RV parks in close proximity to the show site in the Jackson County Parks System at [Blue Springs Lake](#) and [Lake Jacomo](#). The Jackson County online registration page for campgrounds can be located by clicking [here](#). There are also private RV parks in Grain Valley, Oak Grove, and Odessa.
- **FOOD**: Please feel free to bring in outside food. There will be food available for workers. There are fast food and sit-down restaurants within close driving distance.
- **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available.

DIRECTIONS TO THE TRIAL SITE

- Please be aware that some navigation devices do not know the correct location for All Star Dog Sports. It is advised that you look at a map and find the location before trusting your phone or GPS.
- The site is **located** south of the city of Blue Springs on Highway 7, **just south of the intersection of Hwy 7 and Wyatt Rd, on the west side of Hwy 7.**
- If you are coming from the north (I-70), it is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.
- If you are coming from the south, it is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of the Storage Mart storage facility. Hwy 7 is divided by a median so it will be necessary to drive north of the site and make a U-turn at Wyatt Road.
