VMO: Our judge is not a VMO. If your dog needs to be measured prior to running, please arrive at the trial with enough time before your class to allow for the judge to measure your dog.

COVID: We will comply with all local restrictions and AKC Suggested Best Practices. Any specific Covid restrictions which will be followed at the trial will be posted on the secretary web site DoRightSecretary.com.

If you are not feeling well please stay home. Social distancing at the trial is **strongly** encouraged. While masks are not required, we **strongly** urge that exhibitors wear a mask while inside the building. The mask situation may change if county COVID restrictions change between now and the trial date. Any current COVID guidelines for the trial will be posted on the trial site at DoRightSecretary.com under the Covid Instructions heading.

FINAL RUN ORDER: The final run order will be constructed after move ups close on Monday January 22, 2024 at 6:00 pm. The final run order will be posted on DoRightSecretary.com under the Running Order heading.

MAPS: Printed maps will not be provided at the trial. The maps will be posted on Agility Gate each day and on DoRightSecretary.com. Printed copies will be posted in the main building at All Star Dog Sports and in the crating Annex.

In addition to using the Agility Gate app, the run order will be displayed each day at the trial on a monitor to make the running order available to all exhibitors. If you are unable to check in via the Agility Gate app, any exhibitor with the app can check you in, or you can request that the Gate Steward check you in.

ANNEX CRATING:

Please be aware we are instituting new crating rules in place for the Annex in an attempt to alleviate some of the problems with space and due to the addition of new flooring.

- No one will be allowed to set up in the Annex the day or evening prior to the trial except the Cleaning Angels that are cleaning the building on Sunday, if they are running a dog in the trial.
- Exhibitors will not be allowed to save space for other exhibitors.
- The Trial Committee will have space reserved and should have access to the Annex first.
- Mats must be used to protect the new flooring in the annex. It must be under your crate and chair.
 Please do not take up any additional space with your mat. There is a \$10 fine for spills and
 accidents on the surface. If you spill something or have an accident, please put your \$10 in the red
 money box in the main entryway to the right of the office.
- Unentered dogs must be in crates that are stacked! We understand people have reasons they need to bring unentered dogs, but either stack the crates or crate the dogs together.
- Chairs must be placed in front of crates. Please bring reasonably-sized chairs.

SITE INFORMATION

- **BUILDING**: The building is climate controlled; indoor restrooms.
- <u>BUILDING SET-UP INFORMATION</u>: THE BUILDING WILL NOT BE AVAILABLE FOR GENERAL SET-UP ON THURSDAY. The building will open at 8:00 a.m. Friday morning.
- <u>CRATES</u> may be left overnight; however, Greater Kansas City Dog Training Club will not be responsible for any lost or damaged items left at the show site. No dogs allowed overnight in the building. Indoor crating is available in a climate-controlled crating room on the south side of ASDS. Crating might be a little tight at the site, so please conserve space by using wire crates and stacking crates whenever possible. Also, please leave the area along the tree line on the south side of the parking lot for exhibitors crating out of their vehicles. More information about crating set-up will be included in the confirmation letter.
- <u>PARKING</u>: There is close parking, but please park conservatively. Please reserve parking along the south tree line for exhibitors crating out of vehicles.

RV PARKING:

- Overnight RV parking is not allowed at the trial site.
- Daytime parking for small RVs will be limited to four. Please contact Neida Heusinkvelt, 913 530-3558.
- There are RV parks in close proximity to the show site in the Jackson County Parks System at <u>Blue Springs Lake</u> and <u>Lake Jacomo</u>.
 The Jackson County online registration page for campgrounds can be located by clicking <u>here</u>. There are also private RV parks in Grain Valley, Oak Grove, and Odessa.
- <u>FOOD</u>: Please feel free to bring in outside food. There will be lunch and drinks available for workers. There are fast food and sit-down restaurants within close driving distance.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available.
- <u>VENDING</u>: There isn't space available for vendor tables but feel free to bring items to sell out of your vehicle or promotional information on your products. Please contact <u>Neida Heusinkvelt</u>, 913 530-3558 with questions.

- <u>SPECTATORS:</u> Spectators will not be allowed to have their dogs with them. Dogs must be crated unless you are waiting to run, are running, or are exercising your dog(s). No other dogs will be allowed in the spectating area.

FOOD

- There are fast food restaurants and sit-down restaurants within 5 minutes of the show site.
- There will be lunch, snacks, and drinks available for workers. Please feel free to bring in outside food.

DIRECTIONS TO THE TRIAL SITE

- Please be aware that some navigation devices do not know the correct location for All Star Dog Sports. It is advised that you look at a map and find the location before trusting your phone or GPS.
- The site is located south of the city of Blue Springs on Highway 7, just south of the intersection of Hwy 7 and Wyatt Rd, on the west side of Hwy 7.
- If you are coming from the north (I-70), it is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.
- If you are coming from the south, it is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of the Storage Mart storage facility. Hwy 7 is divided by a median so it will be necessary to drive north of the site and make a U-turn at Wyatt Road.
