## SITE INFORMATION

- **BUILDING:** The building is climate controlled; indoor restrooms.
- **BUILDING SET-UP INFORMATION:** **THE BUILDING WILL NOT BE AVAILABLE FOR GENERAL SET-UP ON THURSDAY.** The building will open at 7:00 a.m. Friday morning.
- **CRATES** may be left overnight; however, Agility Ability of Greater Kansas City will not be responsible for any lost or damaged items left at the show site. No dogs allowed overnight in the building. Indoor crating is available in a climate-controlled crating room on the south side of ASDS. Crating might be a little tight at the site, so please conserve space by using wire crates and stacking crates whenever possible. Also, please leave the area along the tree line on the south side of the parking lot for exhibitors crating out of their vehicles. More information about crating set-up will be included in the confirmation letter.
- **Electronic Timing:** Electronic timing will be used at these trials.
- **PARKING:** There is close parking, but please park conservatively. Please reserve parking along the south tree line for exhibitors crating out of vehicles.
- **RV PARKING:**
  - **Overnight RV parking** is not allowed at the trial site.
  - **Limited daytime parking** is allowed for small RVs. Please contact Kim Krohn, 816-830-0573 to reserve daytime RV parking.
  - There are RV parks in close proximity to the show site in the Jackson County Parks System at [Blue Springs Lake](#) and [Lake Jacomo](#). The Jackson County online registration page for campgrounds can be located by clicking [here](#). There are also private RV parks in Grain Valley, Oak Grove, and Odessa.
- **FOOD:** Please feel free to bring in outside food. There will be lunch and drinks available for workers. There are fast food and sit-down restaurants within close driving distance.
- **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available.
- **VENDING:** There isn't space available for vendor tables but feel free to bring items to sell out of your vehicle or promotional information on your products. Please contact Janel Davidson, trial chair, with questions.
- **VOLUNTEERING:** Please volunteer to work. Workers will be supported with lunch and drinks. Please sign up using the volunteer spreadsheet located on the secretary website [DoRightSecretary.com](#), or by clicking [here](#).

### DIRECTIONS TO THE TRIAL SITE

- Please be aware that some navigation devices do not know the correct location for All Star Dog Sports. It is advised that you look at a map and find the location before trusting your phone or GPS.
- The site is **located** south of the city of Blue Springs on Highway 7, **just south of the intersection of Hwy 7 and Wyatt Rd, on the west side of Hwy 7.**
- If you are coming from the north (I-70), it is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.
- If you are coming from the south, it is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of the Storage Mart storage facility. Hwy 7 is divided by a median so it will be necessary to drive north of the site and make a U-turn at Wyatt Road.

## Crating Instructions for the Annex

Please be aware we are instituting new crating rules in place for the Annex in an attempt to alleviate some of the problems with space.

- No one will be allowed to set up in the Annex the day or evening prior to the trial except the Cleaning Angels that are cleaning the building on Sunday, if they are running a dog in the trial.
- Exhibitors will not be allowed to save space for other exhibitors.
- The Trial Committee will have space reserved and should have access to the Annex first.
- No mats will be allowed. A small mat/rug/towel will be allowed under your crate to protect the bottom if necessary, provided it is underneath the crate.
- Unentered dogs must be in crates that are stacked. We understand people have reasons they need to bring unentered dogs, but either stack the crates or crate the dogs together.
- Chairs must be placed in front of crates. Please bring reasonably-sized chairs.

Cooperation from exhibitors is appreciated in this matter.
