# **DIRECTIONS TO TRIAL SITE:**

Hwy 12W to SW Regional Airport Road to SW Barron Road. Turn left to fairgrounds and continue straight through gates. Arena is the building on the right (north) and crating building straight in front (Livestock building). If you enter from Hwy 279 you will drive straight into the arena and the crating building will be on your right.

From OK-412E to Hwy 12E.

From MO-49S to Hwy 72E to 279S.

## **SETUP:**

Thursday night setup will be from 3:00 pm to 5:00 pm. Building opens at 7:00am Friday and Saturday, and at 6:30am Sunday.

Parking on concrete by arena is for permitted handicap parkers in the designated handicap spots only. All other parking on concrete at arena is for Trial Committee and Judge only.

Parking on grass or gravel is allowed with the exception of the road from arena to livestock building and the north side of the arena and where marked as a fire zone. We ask that parking on grass closest to the arena be for those crating from vehicles.

## **AGILITY GATE APP:**

## **HEIGHT CARDS:**



EFFECTIVE January 1, 2010 When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during the day of show check in. The judge will measure dogs before runs as time allows.
