VMO: Our judge is not a VMO. If your dog needs to be measured prior to running, please arrive at the trial with enough time before your class to allow for the judge to measure your dog.

FINAL RUN ORDER: The final run order will be constructed after move ups close on Monday January 20, 2025 at 6:00 pm. The final run order will be posted on DoRightSecretary.com under the Running Order heading.

MAPS: Printed maps will not be provided by the club at the trial. However, Mikel Miller may be providing printed maps at the trial sponsored by This Little Farm. Maps will be posted on Agility Gate each day and on DoRightSecretary.com. Copies will be posted in the main building at All Star Dog Sports and in the crating Annex.

In addition to using the Agility Gate app, the run order will be displayed each day at the trial on a monitor to make the running order available to all exhibitors. If you are unable to check in via the Agility Gate app, any exhibitor with the app can check you in, or you can request that the Gate Steward check you in.

▶ ANNEX CRATING:

Please be aware we are instituting new crating rules in place for the Annex in an attempt to alleviate some of the problems with space and **due to the addition of new flooring**.

- No one will be allowed to set up in the Annex the day or evening prior to the trial except the Cleaning Angels that are cleaning the building on Sunday, if they are running a dog in the trial.
- Exhibitors will not be allowed to save space for other exhibitors.
- The Trial Committee will have space reserved and will have access to the Annex first.
- **The blue flooring in the annex must be protected. If you set up on top of blue flooring in the annex you must use a protective mat under your crate and chair. Please do not take up any additional space with your mat. There is a \$10 fine for spills and accidents on the blue matting. If you spill something or have an accident, please put your \$10 in the red money box in the main entryway to the right of the office.**
- Unentered dogs must be in crates that are stacked. We understand people have reasons they need to bring unentered dogs, but the crates of unentered dogs must be stacked or crate the unentered dog must be crated with an entered dog.
- Chairs must be placed in front of crates. Please bring reasonably-sized chairs.

Cooperation from exhibitors is appreciated in this matter.

SITE INFORMATION

- **BUILDING:** The building is climate controlled; indoor restrooms.
- **BUILDING SET-UP INFORMATION:** **THE BUILDING WILL NOT BE AVAILABLE FOR GENERAL SET-UP ON THURSDAY.** The building will open at 8:00 a.m. Friday morning.
- **CRATES** may be left overnight; however, Greater Kansas City Dog Training Club will not be responsible for any lost or damaged items left at the show site. No dogs allowed overnight in the building. Indoor crating is available in a climate-controlled crating room on the south side of ASDS.
- **PARKING:** There is close parking, but please park conservatively. Please reserve parking along the south tree line for exhibitors crating out of vehicles.
- **RV PARKING:**
 - **Overnight RV parking** is not allowed at the trial site.
 - **Daytime parking for small RVs will be limited to only those with reservations.** Please contact [LeeAnn Jahansooz](#) , 316-210-6454. There are RV parks in close proximity to the show site in the Jackson County Parks System at [Blue Springs Lake](#) and [Lake Jacomo](#). The Jackson County online registration page for campgrounds can be located by clicking [here](#). There are also private RV parks in Grain Valley, Oak Grove, and Odessa.
- **FOOD:** Please feel free to bring in outside food. There will be lunch and drinks available for workers. There are fast food and sit-down restaurants within close driving distance.
- **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available.
- **VENDING:** There isn't space available for vendor tables but feel free to bring items to sell out of your vehicle or promotional information on your products. Please contact [Neida Heusinkvelt](#), 913 530-3558 with questions.
- **VOLUNTEERING:** Please volunteer to work. Workers will be supported with drinks and snacks. Please sign up using the volunteer spreadsheet located on the secretary website [DoRightSecretary.com](#). or by clicking [here](#).
- **SPECTATORS:** Spectators will not be allowed to have their dogs with them. Dogs must be crated unless you are waiting to run, are running, or are exercising your dog(s). No other dogs will be allowed in the spectating area.

FOOD

- There are fast food restaurants and sit-down restaurants within 5 minutes of the show site.
- There will be lunch, snacks, and drinks available for workers. Please feel free to bring in outside food.

DIRECTIONS TO THE TRIAL SITE

- Please be aware that some navigation devices do not know the correct location for All Star Dog Sports. It is advised that you look at a map and find the location before trusting your phone or GPS.
- The site is **located** south of the city of Blue Springs on Highway 7, **just south of the intersection of Hwy 7 and Wyatt Rd, on the west side of Hwy 7.**
- If you are coming from the north (I-70), it is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.
- If you are coming from the south, it is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of the Storage Mart storage facility. Hwy 7 is divided by a median so it will be necessary to drive north of the site and make a U-turn at Wyatt Road.
